

# CITY OF BELDING TIMELINE OF EVENTS: NEW WASTEWATER TREATMENT PLANT AND WATER AND SEWER RATE INCREASE

The need for constructing and implementing a new wastewater treatment plant and the need to increase water and sewer rates has been a frequent topic of discussion at City Council meetings for approximately the past three years.

City Council meetings are held on the first and third Tuesday of every month at 7 p.m. where citizens are *welcomed* and *encouraged* to give Public Comment, voicing their opinions, questions and/or concerns to members of the City Council. <u>Every</u> City Council Agenda offers two opportunities to give Public Comment - the first Public Comment being reserved for agenda items only, the second for <u>any</u> topic.

Meetings *specifically* discussing the new wastewater treatment plant and/or water and sewer rate increases, including public hearings, were topics of discussion at the following City Council meetings, offering city residents *numerous* chances to both become educated on and to comment on these issues.

### **Historical Facts**

Official city records conclude that the existing wastewater treatment plant and lagoons are/were regularly inspected and maintained by us/our predecessors. The current system is/was not neglected, it (fortunately) has far surpassed its life expectancy.

### **Mandate**

The construction of a new wastewater treatment plant was not put to a vote of the people as the City of Belding was MANDATED by the State of Michigan Department of Environment, Great Lakes and Energy (EGLE) to make substantial improvements to the infrastructure of our water system. Thorough studies conducted by experts in this field concluded that constructing a new wastewater treatment plant would be the best long-term solution and most progressive and cost-effective option to comply with this mandate. The City of Belding has sought and continues to seek multiple grant opportunities and funding sources to offset the cost of the new Wastewater Treatment Plant—in fact, the city has already qualified for "Principal Forgiveness" forgiving approximately half of the cost of the new facility!

#### **Funding**

To have the ability to fund the remainder of the project, the City Council had to make the tough and unpopular decision to raise water and sewer rates. Rate studies were conducted and evaluated bringing us to the current amount. In fact, even with the rate increase, Belding's water and sewer rates remain much lower than those of many cities comparable to our size.

Again, the city will continue to seek grants and other funding avenues in an attempt to lessen the burden to our residents.

## <u>Apology</u>

As a result of a computer programming error, the current water and sewer bills included an erroneous \$75 late fee in addition to the increase. We sincerely apologize for this mistake.
